



TSB Balanced Portfolio June 2024

THE INVESTMENT ENVIRONMENT

The April 2024 IMF World Economic Outlook suggests that the world economy will continue growing at 3.2% during 2024 and 2025, at the same pace as in 2023. A slight acceleration for advanced economies—where growth is expected to rise from 1.6% in 2023 to 1.7% in 2024 and 1.8% in 2025—will be offset by a modest slowdown in emerging market and developing economies from 4.3% in 2023 to 4.2% in both 2024 and 2025. The forecast for global growth five years from now—at 3.1%—is at its lowest in decades.

Global inflation is forecast to decline steadily, from 6.8% in 2023 to 5.9% in 2024 and 4.5% in 2025, with advanced economies returning to their inflation targets sooner than emerging market and developing economies. Core inflation is generally projected to decline more gradually. The global economy has been surprisingly resilient, despite significant central bank interest rate hikes to restore price stability.

Global Equity Markets

During June, global equity markets saw good gains. The FTSE All-World Index (USD) increased by 3.1% during the month, ending at a 12-month high, while growing by 18.2% over the past 12 months.

South African Financial Markets

In South Africa, the JSE All Share Index increased by a further 4.1% during the month, ending 2.0% below its 12-month high while growing moderately by 9.1% over the past 12 months. During the month, the JSE Industrial-25 Index increased by 1.6%, the JSE Resources-10 Index declined by -3.7%, and the JSE Financial-15 Index increased sharply by 14.5%. The ZAR strengthened by 3.3% against the USD, the SA Government Bond Index gained 5.2% and the JSE SA Property Index increased by 6.0%.

Investment Portfolios

Balanced Portfolios performed well over the past twelve months, outperforming their benchmark by an estimated 2.1%.


Portfolios continue to see the advantage of broad diversification across multiple risk factor exposures and diverse sources of portfolio return. Market risk exposures remain balanced to reduce the risk of capital loss. Portfolios will continue to be cautiously re-positioned into attractively priced high-quality assets to achieve strong long-term returns.

PORTFOLIO PERFORMANCE

During June, TSB Balanced Portfolios increased moderately by 2.12% with 95% of portfolios performing within a range between 2.00% and 2.25%.

Over the past 12 months, portfolios increased by 12.05%, having achieved a net annualized average growth rate of 7.11% over the past three years, and 6.39% per year, since inception on 30 June 2011*. This can be compared with the annualized average inflation rate of 5.22% over the same period.

Strategically, portfolios are well positioned, and the objective remains to add incremental value over time. While seeking opportunities to increase investment performance, risk management will always remain the priority, specifically seeing through this period of elevated market volatility. It is necessary for investors to remain disciplined and not overreact to short-term market movements.

We expect both the high level of uncertainty in the investment environment and the high level of financial market volatility to persist. It follows that we will continue to closely monitor portfolio positioning and risk exposures.
